Linn Mar District Plan Follow-up items:

A long-term plan is needed because Ed confirmed that Indian Creek will have portable pods next year.

ALICE Safety Drill Training

The ALICE training continues at Westfield. This training gives students and staff the skills to respond to an intruder wanting to harm them. If the intruder is outside the building the school goes into lock down. However, if an intruder gets into the building the best thing to do is evacuate the building. This will result in students going to a safe location (Twin Pines Baptist Church). The police and buses will also meet them at this location. In an actual emergency, parents would be notified to pick-up students at bus transportation center in Marion. Westfield will be doing controlled grade level drills and an entire building drill in the next few months. If you have any questions regarding this training, please feel free to contact Mr. Rogers.
